**Terms and Conditions**

1. Sealed Tenders for the supply and installation of CCTV Cameras in the Vidyalaya are invited by the undersigned on behalf of Navodaya Vidyalaya Samiti Pune Region upto 07.09.2018. Tender should be sent under strong sealed cover marked as tender for the **supply and installation of CCTV Camera**. The tender will be opened in the Chamber of the undersigned at **11.00 hrs. on 07/09/2018 (Friday)**.
2. The tender shall be submitted according to the terms & conditions specified in Para 3 to 10. Unless specified otherwise in the tender, it shall be construed that the terms & conditions stipulated here under have been agreed to.
3. The rates should be including freight/transportation and should include excise duty, sales tax and any other taxes, or imposition whatever liable in respect of the supplies.
4. There should not be any over-writing or corrections in the tender. If a figure is to be amended, it should be neatly scored with fresh figure written & correction to be attested with date. In the absence of the attested signature the tender is liable to be rejected.
5. The Navodaya Vidyalaya Samiti does not bind itself to accept the lowest tender and reserves the right to accept the tender in whole or in part i.e., with respect to all the articles mentioned in the attached statement as it may decide.
6. On acceptance of the tender it will become a contract and the contractor, shall be bound by the terms and conditions of the tender.
7. The Person/persons, whose tender is accepted, hereinafter called the contractor/supplier shall deposit an earnest money of Rs. 2000/- in the form of Demand draft in favour of Principal, Jawahar Navodaya Vidyalaya, Canacona, payable at SBI, Canacona, along with tender which shall be refunded in the event of rejection of the tender. The earnest money will be forfeited in the event of failure to comply with the contract. In the event of the tender being accepted, the earnest money will be adjusted towards Security Deposit, which shall be, payable at the rates mentioned below: -

### **Security Deposit at 10% of the total amount**

If the contractor is not agreeable to pay Security Deposit the reasons therefore should be specified and the undersigned reserves the right to accept or reject the request.

8. If the contractor/supplier fail to supply the articles within the time stipulated in the letter of acceptance by the undersigned, the undersigned shall be at the liberty to purchase the articles from the market or get the rest of the contract completed by any other person or firm and the difference of price, if any, shall be deducted from the earnest money/security deposit and in case any amount in excess of security deposit paid by the undersigned the contractor shall be liable to pay the amount.
9. The quantity of the articles indicated in the attached statement may be increased or decreased at the discretion of the undersigned without assigning any reason.
10. Prior to acceptance of the tender, the undersigned reserves the right to call for samples and demonstration and the contractor shall be liable to supply the samples or give the demonstration free of cost.
